

Some EMRP detailled issues

<u>Reporting</u> delayed in several cases:
2009 call 3 final reports not yet completed
2010 call 8 projects have still not submitted a first draft of their final reports – they are at least 5 months overdue now.

The MSU is also behind in its target in replying to the reports we have received – 27 replies have been outstanding for more than 45 days. This is due to the focus on contract negotiation in the first 3 months of

the year, the backlog will be reduced over the summer.

RPot call

- improved call scope, and training events in Sarajevo and Tallinn around the stage 1 → reduced the number of inappropriate PRTs submitted this year.
- However, the sub-committee still regarded half of the 12 PRTs as out of scope and those PRTs selected to contribute to the SRTs still require much work to introduce a strategic approach and clear research objectives.




