Grey-out CMCs



- Bulgaria (BIM): 1 CMC in length (June 29, 2009)
- France (LNE): 3 CMCs in pressure greyed out since April 24, 2009 were deleted in May 2, 2014
- France (LNE): 3 CMCs in flow (November 24, 2012)
- Belgium (SMD): all the 30 electricity CMCs (August 13, 2013) + 6 TF CMCs (February 4, 2013) 6 CMCs reinstalled on November 28, 2014
- Finland (MIKES): 6 CMCs in force/torque (August 27, 2012)
- France (LNE-ENSAM): all the CMCs greyed out (3 CMCs – August 13, 2013)
- IAEA: 1 CMC in ionizing radiation

Other Issues



- 2 EURAMET institutes (MIRS/UP-ZRS/LPOO and MIRS/ZAG/SM 480) have no CMCs 5 years after approval of their QMS
- 23 EURAMET institutes having CMCs published on the BIPM KCDB did not issue a single calibration certificate with the CIPM MRA logo in 2014.
