## **INFORMATION ON COOMET ACTIVITIES**

#### IMPLEMENTATION OF COOMET PROJECTS

There are **514 proposed projects** as of 31 December 2010.

The work on **90 agreed projects** (**6** of which are on-going) was carried out in 2010.

94 proposed projects are under agreement.

**30 new projects** were proposed in 2010:

- 7 for "Thermometry and Thermal Physics",
- 5 for "Reference Materials",
- 4 for "Training and Raising the Proficiency Level of Experts",
- 3 for "Electricity and Magnetism",
- 2 for "Physical Chemistry",
- 2 for "Flow Measurement",
- 2 for "Length and Angle",
- 1 for "Acoustics, Ultrasound, Vibration",
- 1 for "Mass and Related Quantities",
- 1 for "Ionizing Radiation and Radioactivity",
- 1 for "Legal Metrology",
- 1 for "Research and Development".



In 2010 16 projects were proposed by Russia; Ukraine and Belarus proposed 5 projects each; Germany proposed 1 project; Georgia and Kazakhstan proposed 1 project each.

16 proposed projects are related with regional comparisons of measurement standards of physical units. 6 projects are aimed at the organization of meetings of the Structural Bodies as well as events within COOMET. 5 projects aim at the development of COOMET documents. Such activities as elaboration and testing of reference materials, identification of the needs of COOMET NMIs in training and on-the-job training, as well as development of a conception for joint research in metrology in COOMET member countries are covered by 1 project each.

During 2010 **12 projects were agreed**, **5** of them are related with comparisons in various subject fields (AUV, T, QM, RM), included into the Programme of Comparisons of Measurement Standards of COOMET NMIs.

The total **number of projects completed** during 2010 is **22**. They are aimed at carrying out comparisons of measurement standards of COOMET NMIs, developing reference materials and holding meetings of Structural Bodies and COOMET events.

#### IMPLEMENTATION OF THE CIPM MRA

**1770** CMC lines declared by NMIs of COOMET member countries were published in the KCDB as of 31 December 2010, including by countries and types of measurements:

15 comparisons were registered in the COOMET project database in 2010; however only 2 of them (supplementary comparisons) were then registered in the KCDB. 4 comparisons (3 supplementary and 1 key comparisons) previously registered in the KCDB were completed in 2010.

The participation of COOMET in the implementation of the CIPM MRA set the following tasks for its participants:

- planning and organization of regional key and additional comparisons of standards;
- holding of regional and inter-regional review of data on calibration and measurement capabilities (CMCs) of NMIs of COOMET member countries and other RMOs submitted to BIPM for approval and publication at its website;
- carrying out the review of Quality Management Systems (QMS) of NMIs of COOMET member countries that are the participants of the CIPM MRA.

There is an essential methodical base of cooperation created in COOMET which is constantly updated and enlarged.

The second cycle of QMS peer reviews was passed by 4 Russian NMIs (VNIIM, VNIIMS, VNIIOFI, VNIIFTRI) in 2010 and Belarusian BelGIM and 2 Ukrainian NMIs (NSC "Institute of Metrology" and DP "Ukrmetrteststandart") in April and May 2011.

## **COOMET WEB RESOURCES**

On 26 October 2010 during the 15<sup>th</sup> meeting of the COOMET President's Council the **new** COOMET **web-portal** (<u>www.coomet.net</u>) was launched which will function together with the COOMET website (<u>www.coomet.org</u>).

Unlike the COOMET website **new** COOMET **web-portal** will be used for answering the needs of COOMET members:

- storage, retrieval, exchange of data communication and
- coordination, organizing meetings and events, promoting the RMO and NMIs.

Two training workshops were held in March and December 2010 for on-line editors of the pages of COOMET member countries and those of Technical Committees of COOMET. These pages are now filled in by designated on-line editors.

## 21 COOMET COMMITTEE MEETING

The 21<sup>st</sup> COOMET Committee meeting was held on 27–28 April 2010 in Yerevan, Armenia.

Representatives of 14 COOMET Member Countries (Armenia, Belarus, Georgia, Germany, Kazakhstan, Kyrgyzstan, Cuba, Lithuania, Moldova, Russia, Romania, Slovakia, Uzbekistan and Ukraine) took part in the meeting. Mr. Alan JOHNSTON, CIML President; Mr. Stephen PATORAY, BIML Director; Mr. Andrew HENSON, International Liaison Officer of BIPM; Mrs. Nataša MEJAC VUKOVIC, WELMEC Chairperson, also reported at the meeting on the activities of their organization.
