- 1) In CC-KCs a small number of NMIs are taking the leadership as pilot lab. In RMO comparisons there is a much broader distribution of the workload
- Countries with large number of CMCs have this in most cases due to the high number of CMCs in chemistry. In the CMC statistics without chemistry, there is a much more homogeneous distribution of number of CMCs.

G09.13 Conclusions and reflections over last 3 years

EURAMET Chairperson Kamal Hossain, gave some reflections on his three years of Chairmanship and thanked for the privilege to have been Chair.

He highlighted some of the important achievements of EURAMET in the last three years:

- Establishment of the EURAMET strategy
- The enormous and successful effort on getting EMPIR approved by the EU and implementation by EURAMET
- The organizational development of EURAMET towards a more professional organization, in particular with the establishment of the post of a General Secretary and a unified Secretariat
- Establishment of a communication strategy with a new corporate design and new website
- Development of horizontal cooperation between TC-Chairs and better linkage to BoD
- Starting of a discussion process with DIs and their better integration within EURAMET



Kamal emphasized that these achievements were the result of the effort of many people and of good team work, of which we can be proud. He has worked with many good people and got a lot of support.

G09.14 AOB

The leaving TC-Chairs for M and MC, Nieves Medina and Michela Sega thanked the Secretariat team for the received support as TC-Chairs.

Kamal Hossain handed over the chairmanship to his successor Beat Jeckelmann and wished him success for his term.

Beat Jeckelmann emphasized that the standard for being Chair is very high. With EMRP and EMPIR, EURAMET became more professional; important challenges and opportunities still lie ahead. He alluded to some important achievements during Kamal's Chairmanship (establishment of a vision and mission, the Strategic Research Agenda, achieving EMPIR, establishment of new strategic partnerships). Beat stressed that EURAMET is also about diversity of cultures; an aspect which puts high demands on communication but which is at the same time immensely enriching and inspiring. Beat thanked Kamal for his commitment over the past three years, for his strong leadership and for his many contributions to the development of the Association.
