

- The overall opinion of the Panel is that the EMRP is a well managed joint European research programme that has already achieved a relatively high level of scientific, management and financial integration.
- There are significant gaps between expectation and reality in relation to three qualitative impact indicators: capacity building, interaction with the wider scientific community and mobility

- Training for coordinators
- Improve time to contract
- Facilitate inclusion
- Improve mobility grants
- Be more open-minded in selecting the SRTs
- Work better with FP7
- Improve the REG scheme
- Talk more to regulators
- Increase the weighting given to impact
