G06.01 Welcome address

The Administrative Director of DFM Michael Kjær opened the meeting and welcomed the participants to Denmark. He gave an overview on the Danish metrology infrastructure.

The Rector of DTU Anders Bjarklev gave a welcome address on behalf of the hosting organisation of the General Assembly.

G06.02 Opening and adoption of the agenda

EURAMET Chairperson Leslie Pendrill welcomed the participants to the 6th EURAMET GA and gave overview on the sessions of the week. He presented the agenda of this Plenary Session; the agenda was adopted without changes.

G06.03 Chairpersons' Report

Leslie Pendrill presented the "Chairpersons' Report" on EURAMET activities of the last year. Report and slides are attached.



G06.04 EURAMET Administration and Secretariat

Head of EURAMET Secretariat Wolfgang Schmid gave an overview on the activities of the EURAMET Secretariat of the last year. Report and slides are attached.

G06.05 EURAMET Objectives and Strategic Matters

G06.05.01 EURAMET Strategy – overview and implementation

Kamal Hossain, Chair-elect and responsible for the coordination of development and implementation of the EURAMET 2020 Strategy, gave a short overview on the progress in the implementation and the distribution of responsibilities for the 5 strategic objectives within the BoD:

Engagement of key stakeholders

Albert Dalhuijsen EURAMET Chairperson

2) Increase influence with European policy makers and national governments

EMRP-Chair

3) Further develop co-operation in R&D

Janko Drnovsek

4) Deliver high value to members and associates

Maguelonne Chambon

5) Supporting quality infrastructure in Europe and internationally

Kamal emphasised that the input from the members is crucial for EURAMET to achieve its objectives and asked the Delegates to give direct feedback to him and suggest one to three important things that they consider EURAMET should do for its members and associates.

The leaders of each strategic objective gave an overview on the respective goals and actions (see also attached "EURAMET 2020 Strategy"):

G06.05.02 Engagement of key stakeholders

Albert Dalhuijsen introduced this strategic objective and emphasised that one important conclusion of the EMRP midterm evaluation of the EMRP was, that EURAMET has a very good programme, but is not very well known to the outside world. A stronger engagement of stakeholders is needed; the BoD is currently working on identifying the key stakeholders of EURAMET.

He informed that EURAMET has generated a post of a Communications Officer; the call is still open and published on the EURAMET website.

G06.05.03 Increase influence with European policy makers and national governments

Leslie Pendrill gave an overview on the actions related to this strategic objective and focussed on the action to "ensure appropriate results from EMRP projects contribute effectively to the development of European standards of major importance." (see attached slides)

G06.05.04 Deliver high value to Members and Associates

Janko Drnovsek introduced this strategic objective, emphasising the huge variety of different organisations and people in EURAMET and the importance for EURAMET to offer support to all members and associates of the organisation. A focus of the current discussions is how to bring the benefits of the EMRP to the members currently not participating directly in the EMRP and how to design the follow-up programme EMPIR to enable an effective participation of theses members.



Janko announced a break-out session for non-EMRP Members on Wednesday 23 May afternoon, which has the objective to analyse the needs and expectations of these members on the capacity building modules in EMRP and EMPIR.

G06.05.05 Supporting quality infrastructure in Europe and internationally

Maguelonne Chambon explained goals and action plan of this strategic objective. The important partners to intensify the interactions are the EC, the JCRB and the EA. An action plan was presented; see attached slides.

G06.06 European Metrology Research Programme – EMRP

G06.06.01 Status report EMRP & interim evaluation

Duncan Jarvis, EMRP Programme Manager gave an overview on the midterm evaluation of the EMRP, carried out during the last year (see attached slides). The report was published by the Commission (EC) in April 2012 and is available on the websites of the EC and EURAMET. The overall conclusions on the management of the programme were very positive; gaps between expectations and reality were identified in relation to capacity building, interaction with wider scientific community and mobility. Duncan explained the next steps responding to the report and addressing the recommendations.

At the end of his presentation he informed on a newly established EURAMET Impact Prize, which will be awarded this year for the first time. The recipient of the prize is Oswin Kerkhof, form VSL, Netherlands.

G06.06.02 Follow-up programme EMPIR: principles & cornerstones

EMRP-Chair Jörn Stenger focussed his presentation on the preparation of the follow-up programme EMPIR, the "European Metrology Programme on Innovation and Research" (see attached slides).

He explained the envisaged modules and cornerstones of the EMPIR and concept and timeline for drafting the proposal to be provided to the EC. He announced that the discussion will be continued in the Working Session for Delegates Only, in particular to agree the cornerstones and to discuss the national commitments. It is envisaged that EMPIR should have a similar financial value as the current A-185 EMRP.

Furthermore, Jörn outlined that in September 2012 an ex-ante impact assessment for EMPIR will be carried out by the EC and that it will be important to have appropriate material available. In order to support the current efforts of the BoD in this respect, he suggested a secondment for 3 months in summer 2012 for the preparation of such material.

In the following discussion Anneke van Spronssen, WELMEC Chairperson, recommended that the EMPIR proposal should underline that it will be a coordinating activity, why A-185 (and not another funding tool of the EC) is the appropriate instrument, as cooperation among the countries shall be intensified. Another recommendation was to make a wider use of the ministry representatives, not only via meetings, but also via continuous dissemination of written information. Andreas Bauch, TC-TF Chair, acknowledged that it is positive to have new modules like innovation, pre-normative research and capacity building in the EMPIR and raised the question why it is not envisaged to increase, as a consequence the total volume of the programme compared to the A-185 EMRP.



G06.07 BIPM and CIPM MRA

Andy Henson, International Liaison Officer of BIPM, gave an overview on recent developments at BIPM and within the CIPM MRA (see attached slides).

G06.08 Report from EURAMET horizontal TCs

G06.08.01 TC-Q

Pavel Klenovsky, TC-Q Chair gave an overview on the activities of the TC Quality during the last year and on the results of its annual meeting from 8 to 9 March 2012 in Warsaw, Poland (see attached slides). An important conclusion was that end of this year the QMS of all NMIs and A-DIs participating in the CIPM MRA will be evaluated via peer review or accreditation.

G06.08.01 TC-IM

Maguelonne Chambon, TC-IM Chair gave an overview on the activities of the TC for Interdisciplinary Metrology during the last year (see attached slides).

G06.08.03 TC-IM FG-FNMID

Janko Drnovsek, gave a short oral report on status and activities of the Focus Group for "Facilitating National Metrology Infrastructure Development". Activities are running in a routine way. Due to the retirement of the previous Chair Arnold Leitner, the EURAMET BoD delegated responsibilities for the FG-FNMID to the Janko Drnovsek for an interim period.

Janko informed on the status of the transfer of the FG to a joint EURAMET-WELMEC TC for Metrology Infrastructure Development. Legal ground for the operation of joint committees is now established within the revised version of the EURAMET RoP. In close interaction with the WELMEC Chairperson, first ToR have been drafted. Due to recent discussions, this new TC shall have an important role in capacity building within EMPIR. The concepts for this are currently under development and the draft ToR will be adapted as soon as its role in EMPIR is defined. The next step is that EURAMET and WELMEC have to approve the ToR; after approval by both organisations the new TC can be established.

G06.09 Report from Working Session Delegates Only

Chairperson Leslie Pendrill presented the important results from the preceding GA Working Session – Delegates Only:

- After this GA the Chairmanship will pass over to Kamal Hossain (NPL, UK), who had been elected at the last GA as new EURAMET Chair.
 Leslie Pendrill will continue in the BoD for one year as past-Chair.
- Two BoD members have been re-elected for a second term of office (till GA 2014):

- The GA decided that the preparation of the EMPIR shall continue along the cornerstone paper as
 presented to the GA. A draft of the full proposal shall be presented end of September to the Delegates
 for approval.
- The financial report 2011 (together with the reports on internal and external audit) has been accepted by the Delegates. The Chairpersons' report has been endorsed. Chairpersons and Head of Secretariat have been discharged of responsibility for the financial year 2011.
- In order for EURAMET to continually meet its non-profit objectives and fulfill its obligations regarding the implementation of the EMRP, the GA decided to transfer the amount made up of surplus and released operating capital reserve from 2011 to reserves (operating capital and uncommitted reserve).
- A budget of 247 k€ for member services in 2013 has been approved.
- The annual fees to be paid by Members & Associates in 2013 shall be the same as in 2012.
- A revised version of the EURAMET Rules of Procedures (RoP) has been approved (see attached documents).
- The EURAMET GA 2013 will be in the week from 27 to 31 of May in Iceland.
- The EURAMET GA 2014 will be in Albania; date to be defined.
