## **INFORMATION ON COOMET ACTIVITIES**

#### **IMPLEMENTATION OF COOMET PROJECTS**

There are 604 proposed projects as of 30 April 2013.

The work on **83 agreed projects** (6 of which are on-going) was carried out as of 30 April 2013. **111 proposed projects** are under agreement. **43 new projects** were proposed in 2012:

- 10 for "Mass and Related Quantities",
- 7 for "Physical Chemistry",
- 7 for "Length and Angle",
- 6 for "Electricity and Magnetism",
- 4 for "Reference Materials",
- 2 for "Legal Metrology",
- 1 for "Acoustics, Ultrasound, Vibration",
- 1 for "Flow Measurement",
- 1 for "Photometry and Radiometry",
- 1 for "Ionizing Radiation and Radioactivity",
- 1 for "Thermometry and Thermal Physics",
- 1 for "Time and Frequency",
- 1 for "Information and Training".

In 2012 25 projects were proposed by Russia; 13 – by Ukraine; 2 – by Georgia; Azerbaijan, Kazakhstan and Uzbekistan proposed 1 project each.

**35 proposed projects** are related with regional comparisons of measurement standards of physical units. **3 projects** are aimed at the organization of meetings of the Structural Bodies as well as events within COOMET. **5 projects** are aimed at the development of COOMET documents.

#### IMPLEMENTATION OF THE CIPM MRA

The participation of COOMET in the implementation of the CIPM MRA set the following tasks for its participants:

- planning and organization of regional key and additional comparisons of standards;
- holding of regional and inter-regional review of data on calibration and measurement capabilities (CMCs) of NMIs of COOMET member countries and other RMOs submitted to BIPM for approval and publication at its website;
- carrying out the review of Quality Management Systems (QMS) of NMIs of COOMET member countries that are the participants of the CIPM MRA.

There is an essential methodical base of cooperation created in COOMET which is constantly updated and enlarged.

NISM (Moldova) successfully passed the peer review on 5–6 November 2012 for the first time.

Second peer review of **DP "Ivano-Frankovskstandartmetrologia" (Ukraine)** was conducted on 6-7 December 2012.

Second peer reviews of **INIMET (Cuba)**, **CENTIS-DMR (Cuba)**, **CPHR (Cuba)** was conducted in March 2013.

Peer review of GEOSTM (Georgia) is planned for autumn 2013.
