# 27<sup>th</sup> COOMET Committee Meeting

On 26–28 April 2016, according to the schedule of meetings of COOMET structural bodies, the 27<sup>th</sup> meeting of COOMET Committee and the 15<sup>th</sup> meeting of COOMET Joint Committee for Measurement Standards were held. The meetings took place in Minsk, Belarus.

The objectives of the activities were to discuss issues on COOMET development, implementation of the "Arrangement on Mutual Recognition of National Measurement Standards and Calibration and Measurement Certificates Issued by National Metrology Institutes" (CIPM MRA), performance results in "Legal Metrology", "Information and Training", "Quality Management" and cooperation with the International Bureau of Weights and Measures (BIPM) and the International Bureau of Legal Metrology (BIML).

COOMET Committee members and their official representatives, Chairpersons of COOMET Technical Committees and representatives of COOMET National Secretariats from 17 COOMET member-countries (Armenia, Azerbaijan, Belarus, Bosnia and Herzegovina, China, Cuba, Georgia, Germany, Kazakhstan, Kyrgyzstan, Lithuania, Moldova, Russia, Slovakia, Tajikistan, Uzbekistan and Ukraine), representatives of international metrological organizations: Ch. Kuanbaev, International liaison & Communication Department of BIPM, and Ya. Danmil, Deputy Director of the BIM took part in the 27<sup>th</sup> COOMET Committee meeting.

19 agenda issues were considered at the meeting, including:

- main results of COOMET activities in 2017;
- set of issues related to the implementation of CIPM MRA;

• results of the 36<sup>th</sup> and 37<sup>th</sup> meeting of JCRB and the 51<sup>st</sup> meeting of the International Committee of Legal Metrology (CIML) and COOMET tasks arising from its decisions;

- COOMET Quality Forum activities;
- COOMET activity in Legal Metrology;
- COOMET activity in Information and Training;

• establishment of COOMET structural bodies and appointment of Chairpersons of Technical Committees and Subcommittees;

• election of COOMET President.

The regular election of COOMET President was held during the 27<sup>th</sup> COOMET Committee meeting. Valery Hurevich, Director of BelGIM, Belarus, was elected as a new COOMET President by the results of the secret voting. According to the COOMET Rules of Procedure, the new President will assume his duties on the 28<sup>th</sup> meeting of COOMET Committee in a year.

## **Implementation of COOMET projects**

The general amount of projects registered by COOMET Secretariat since 1991 is **717 projects** as of 31 March 2017.



**28 new projects** were proposed during this period: **6** – for "Reference Materials", **4** – for "Mass and Related Quantities", "Physical chemistry" and "Electricity and Magnetism", **3** – "Legal metrology" and "Length and Angle", **1** – for "General questions concerning measurements (General metrology)", "Acoustics, ultrasound, vibration", "Thermometry and Thermal Physics", "Information and training".

21 of the new projects are related with regional comparisons of measurement standards of physical units, 5 projects are aimed at the development of COOMET Recommendations and Documents, 1 - for organization and holding of meetings of the Structural Bodies as well as events within COOMET, 1 - to carry out training of metrologists.

During the reporting period 11 projects were agreed, 15 – completed, 6 – excluded.

In general, COOMET Program of Comparisons for 2017 includes 136 projects.

### VII International Competition of COOMET "The Best Young Metrologists 2017"

VII International Competition of COOMET "The Best Young Metrologist" will be held 17–18 May 2017 in Astana, Kazakhstan, with the participation of the young metrologists from other RMOs. The language of Competition will be English

The Scientific Committee of the Competition includes leading metrologists of Belarus, France, Germany, Kazakhstan, Russia, South Africa, Ukraine and USA from international (BIPM, BIML) and regional (AFRIMETS, COOMET, EURAMET, SIM) metrology organizations.

There are presented 36 papers of 10 countries from 3 PMO's – COOMET, EURAMET and SIM.
