 TC-IM to analyse the possibilities for e-learning activities of EURAMET in coordination with the members, make recommendations and report back to BoD.

CIPM-MRA – broader scope CMCs



At the JCRB meeting the recommendations of the WG was discussed, Euramet chairperson brought a proposal about broader scope CMCs forward, but the participants were reluctant

TC-IM was asked to support Euramet position and we discussed the issue at the last meeting, we are collecting some examples and will bring them forward at least by the end of June

MATHMET – future plans:



- Stronger support for interdisciplinary metrology topics such as mathematics and statistics in EMPIR calls
- Backing of PRTs with math background in SRT selection
- Late stage Call in EMPIR or other support action for Centre and similar infrastructures
- Possibility of integration of centres like MATHMET into EURAMET, e.g. as EURAMET Centres?

Guides:



Action 2016 – 04 Responsible: EA and EURAMET

To establish a network for exchange of information about the guides between EA LC and EURAMET TC-IM and to invite EUROLAB to participate. EA to put a link to the EURAMET guides on its website

- Regulations about the use of guides vary from country to country
- EA requested some kind of policy on how EURAMET guides can be kept updated.
- Currently, it depends on the TC whether guides are being updated or not (some TCs do not feel responsible or lack resources)

Guides:



- Guides are not updated strategically (sometimes stakeholders get informed, sometimes they don't)
- with a more systematic approach the expectations of EA would be getting up which could lead to problems with resources
- > no commitment to EA

→ TC-IM Chair has to raise the question of guides again at TCC meeting

Regulation Scrutiny Group:



EU Regulations

- → affect the work of all TCs
- → Metrology for regulation and conformity assessments are a key part of the missions of many (but not all) NMIs
- → EURAMET has no body or initiative to address regulations strategically and comprehensively

Regulation Scrutiny Group:



- Create a "Regulation Scrutiny Group" (RSG) under EURAMET - RSG would address both EMPIR (II) related issues and broader issues for the benefit of the NMIs and TCs
- approval of EMPIR committee and BoD was/is requested

Formation of RSG group:

- Chairperson Duncan Jarvis
- TC-IM Chair Robert Edelmaier
- One other BoD member: Jörn Stenger
- group shall coordinate input from a network of experts, rather than creating a big committee
- Support and input from TC-IM members necessary

New TC-IM Chair:



My term will end at the next GA

Successor candidates for an upcoming vacant TC-Chair are proposed first by the TC itself. The election of a new TC-Chair will usually be done ahead of the GA. Timing should be such that the incoming TC-Chair can join the spring joint meeting of BoD and TCCs as observer.

TC-IM proposed a new chair, election will be performed in autum (together with other TC-Chairs
