G13.01 Welcome address

Claes Winzell welcomed the participants of the 13th EURAMET General Assembly (GA) to Borås on behalf of the host RISE.

G13.02 Opening and adoption of the agenda

Chairperson Hans Arne Frøystein opened the Plenary Session of the 13th EURAMET GA. The agenda was adopted without changes.

G13.03 Report from the Working Session Delegates Only

The working session for Delegates only took place the afternoon before the plenary session. Hans Arne Frøystein gave a short feedback and presented the most important results:

- INM-Moldova was accepted as full member in EURAMET.
- The Designated Institute IH-LQPM (Portugal) was accepted as Associates (A-DI). Designation area is Chemistry & Biology: sea water, sediments.
- Maria Luisa Rastello (INRIM, Italy) was re-elected as EURAMET Vice-Chairperson (GA) for a second term.
- Robert Edelmaier (BEV, Austria) was re-elected for a further term in the BoD; Isabel Godinho (IPQ, Portugal) and Beat Jeckelmann (METAS, Switzerland) were elected as new BoD members.
- The following persons were re-elected as TC Chairs for the period 06/2019 to 06/2021:

TC-AUV Stephen Robinson (NPL, UK)
TC-PR Stefan Kück (PTB, Germany)
TC-TF Peter Whibberley (NPL, UK)

- Jacco de Pooter (VSL, Netherlands) was elected as next TC-IR Chair, to start in 06/2020.
- The GA approved the "Strategy for a future collaboration between EURAMET and WELMEC".
- The GA welcomed the initiatives for EURAMET to intensify working on digitalisation, in particular the GA supported the proposals:
 - that the TC-IM identifies experts for a working group; WELMEC experts should be involved,
 - to use the possibility of secondments for supporting the TC-IM projects on digitalisation,
 - that the BoD takes the challenge to define a strategy.
- The GA appointed the following members for the GA working group on EMNs: current mentors Hans Arne Frøystein, Beat Jeckelmann, Jörn Stenger, Maguelonne Chambon, Maria Luisa Rastello, plus two further delegates Martti Heinonen and JT Janssen. Beat Jeckelmann was appointed as convenor of the GA working group on EMNs.



- The GA welcomed the initiative of TC-IM to analyse available information about EMNs and take necessary actions within TC-IM to foster intra-EURAMET interactions and identify relevant opportunities for members.
- The GA took note of the progress made towards a next European metrology programme and encouraged the BoD to continue working along the presented concepts.
- The EURAMET GA 2020 will take place in Vienna, Austria in the week from 25 to 28 May.

G13.10 European Metrology Networks

G13.10.01 Status and first achievements

Duncan Jarvis gave an overview on the status of establishment of the first 6 European Metrology Networks (EMN) which were approved by the GA last year: Mathmet, Quantum Technologies, Laboratory Medicine, Smart Electrical grids, Energy Gases, and Climate and Observation. Further EMNs are in preparation or consideration, but there were no new EMNs approved this year. The BoD had reviewed the existing EMNs. Good progress was observed, but also several barriers for their development could be identified and were shown in Duncan's presentation. Duncan concluded his presentation listing the workshops planned for this year. He emphasised on a workshop for NMI directors on EMN progress and programme commitment on 10 December in Berlin.

In continuation, Thomas Damitz, a new Secretariat staff member ("Networks Officer"), presented some initial results of a currently running survey on medical device regulation and post market surveillance. There is a significant number of EURAMET members which could have interest on an EMN about the Medical Device Regulation.



G13.10.02 EMN mapping

Maguelonne Chambon and Jörn Stenger had initiated an EMN mapping, analysing which of the "Horizon Europe" and "Horizon 2020" categories are addressed by existing or proposed EMNs. EMNs were sorted along these categories, plus an additional category for "NMI backbone EMNs". A good coverage of the Commission's categories is observed. One gap on "clean energy, photovoltaic and wind" was identified. In the following discussion, this was considered as a relevant area which should also be covered by an EMN.

In the discussion the question was debated how many EMNs could be expected and how many could be sustained by the EURAMET members on a long term. It was argued that in a first phase the successful implementation and operation of the existing EMNs must be ensured. Based on that experience a perspective for additional EMNs can be developed.

Furthermore, EURAMET members were encouraged that they should select a few EMNs where they can actively contribute, rather than trying to cover all areas.

Anne's presentation focussed on the activities of high priority, which were those related to EMNs and the redefinition of the SI. G13.13 Expectations from DG Research & Innovation to EURAMET

Seán O'Reagain, Deputy Head of Unit "Advanced Manufacturing Systems and Biotechnologies" of DG Research & Innovation gave an overview on the state of play of European partnerships under Horizon Europe. His PP-slides can be found among the meeting documents.

Among the proposals for institutionalised partnerships based on Article 185 / 187, the EURAMET initiative is listed in partnership area 3 on "European leadership in Metrology including an integrated Metrology system". Seán explained that this is still not the final list, as some countries believe that there are too many areas existing. Seán showed the milestones in preparation, adoption and launch of Article 185 / 187 initiatives: Consultation of Member States, public consultation and impact assessment will be concluded within 2019; the adoption of the Commission proposals is scheduled for the first quarter of 2020. The accepted initiatives should launch in early 2021.

On the question for his main advice what EURAMET delegates and BoD should do, Seán recommended to continue working with the representatives in the Council of Ministers, keep the technical work groups informed and demonstrate how metrology is supporting the goals of Horizon Europe as an important element in all areas.

G13.14 Important developments amongst EURAMET Members & Associates

There was no presentation given.

G13.15 Dialogue with the BoD

Hans Arne was opening the dialogue with the BoD. He expressed his expectation that such a session helps to open the relationship from delegates and other people to the BoD. He invited the participants to ask also critical questions.

Duncan Jarvis was moderating the session. From part of the BoD Hans Arne Frøystein, Maguelonne Chambon, Erkki Ikonen, Beat Jeckelmann, Isabel Godinho, Jörn Stenger and Robert Edelmaier were represented.

The first question from Marc Pieksma was addressing the EMN-discussion. He asked how we can ensure that EMNs will be successful and sustainable. Beat emphasised on the importance to make first the running EMNs a success; he expects that the workshop with NMI directors in December 2019 can contribute convincing them to provide the required support from the NMIs. Jörn stated that ENMs are not sustainable by definition. Inherent stability needs to be achieved; all participating NMIs must have a strong interest. The EMNs must survive by themselves, not via pushing from the top. Erkki emphasised that it is the NMIs who must make the EMNs a success; EURAMET has to provide the appropriate frame. Isabel and Robert recalled on the importance that all EURAMET members, also the small NMIs are participating, identifying at least one EMN which is of high importance for them. Hans Arne recalled the presentation on EMN-mapping (G13.10.02). It is important to understand the future challenges and go ahead in these directions, in order to ensure the support of the European Commission.



Jean-Remy Flitz drew the attention to the role of the TCs in supporting the EMNs. Road mapping of the TCs should be the chamber for brainstorming regarding EMNs. Maguelonne confirmed that the BoD is very much convinced on the importance of the TCs; a close connection between EMNs and TCs must be ensured.

Miruna Dobre asked if EURAMET has the right impact studies ready for the areas requested by the Commission. Duncan pointed out that we have many impact studies on the website, that keeping track becomes already difficult. Jörn added that we need to make them more visible. Beat concluded that this is very much related with the purpose to create the EMNs, to explain impact properly at the stakeholder level. Hans Arne confirmed that a lot of information is available, but we have to discuss with the Commission the examples which we should use.

Jan Petersen asked if it is better to have a smaller number of EMNs and ensure that they are successful, rather than increasing the number too much? Hans Arne confirmed this statement. Jörn added that the idea of the monitoring was to give a flavour what we are covering and to avoid that we miss something which is key for the next programme. He is aware that the resources of NMIs are limited and must be taken into consideration for further establishment of new EMNs.

Sophie Vaslin-Reimann was concerned that the recommendation that NMIs should focus on specific EMNs might increase the difference between smaller and larger NMIs. Hans Arne pointed out that for a non-research focussed NMI it might be easier to join an EMN than a Joint Research Programme (JRP), as the EMNs have a wider spectrum of activities. In addition, the lesser research focussed NMIs can more easily establish National Commitment for JRPs through EMN work. Jörn complemented emphasising on the different possible roles in an EMN, which should give good opportunities for all NMIs, some of them doing research and others dissemination. Beat did not share Sophie's concern: for him it is natural that small NMIs can join less activities, and this will not change due to the EMNs. Robert however believed that the gap between small and big NMIs might increase and emphasised on the important role of capacity building to enable small NMIs having a better participation.

Andy Henson recalled that in the preparation of EMRP (the first co-funded research programme), it was crucial to get the support from the European Parliament (EP). For that purpose, parliamentarians (MEP) were invited to visit the NMIs. He recommended doing the same for the new programme. Jörn supported this proposal. The process should be initiated after the EP elections; the ITRE-Committee should be approached. Duncan informed that the Secretariat can provide details of MEPs that we have been in contact with through our activities in the parliament.

One participant asked how the "lower parts of the traceability chain" (i.e. the calibration laboratories) can be brought better into the metrology community. Jörn responded that the member NMIs have these contacts. He believes that getting these laboratories better involved we can improve our impact.

Jan Petersen asked for the next priorities in EURAMET after Horizon Europe and EMNs. Beat considered that collaboration with Liaison Organisations, in particular with WELMEC should have high priority. Maguelonne mentioned the importance of a good progress in capacity building. Robert saw the most important challenge in making the EURAMET fit for the future by improving the internal organisation. He mentioned as one example which serves for this purpose the workshop with EMN-Chairs and TC-Chairs.

Emma Woolliams asked whether the BoD would consider a formal gender policy, similar to that described by CEN-CENELEC in their presentation. Hans Arne confirmed that there are equal



opportunities to all, without discrimination. Maguelonne recalled that the Vice-Chairperson (GA) is a woman. ¹

Stefan Kück asked for the relations to other RMOs and how EURAMET is perceived by them. Hans Arne recalled the good collaboration among all RMOs and EURAMET's special relationship to COOMET. Hans Arne emphasised on EURAMET's close involvement in and active support to BIPM's Capacity Building & Knowledge Transfer (CBKT) programme. Furthermore, he pointed out that many NMIs beyond Europe were included in EMPIR projects. Jörn added that the global cooperation is not an issue for EURAMET, it is well developed and thus an asset with which we can demonstrate that we have impact on international level. Andy Henson invited EURAMET to have a stronger engagement in the INetQI, the "International Network on Quality Infrastructure".

G13.16 AOB

No further matters were discussed.

Hans Arne thanked the participants of the GA and all speakers. He expressed his thank to the Secretariat for the preparation; special thanks went to Jan Johansson, Stina Hallhagen and Anna Axelsson from the host RISE for the excellent preparation and support during the GA week.

Hans Arne closed the meeting.

Currently, among the 3 Chairpersons there is one woman, among the 6 elected BoD-members there are 2 women, among the 12 TC Chairs there are 5 women, and among the 6 EMN-Chairs there are 2 women.
