1st Day of the Plenary Session – 8th June 2021

G15.01 Welcome address

Chairperson Hans Arne Frøystein welcomed the participants of the 15th EURAMET General Assembly (GA) held exceptionally online due to the covid-19 pandemic. He wished them well and thanked them for joining the meeting.

G15.02 Opening and adoption of the agenda

Hans Arne Frøystein opened the Plenary Session of the 15th EURAMET GA. The agenda was adopted without changes.

G15.03 Report from the Working Session Delegates Only

The working session for Delegates was organised the day before (7th June 2021) the plenary session. Hans Arne Frøystein gave a short feedback and presented the most important results:

- Informing on new and upcoming staff members in EURAMET Secretariat
 - Brian Rambeka, as Administrative Officer, who joined late November 2020
 - Mikko Merimaa, as General Secretary, who will initiate a transition period with Duncan Jarvis as from mid-August 2021. On that occasion, Mikko was given the floor to introduce himself.
- Robert Edelmaier (BEV, Austria) and Isabel Godinho (IPQ, Portugal) were re-elected for a further term in the BoD running from 06/2021 to 05/2023
- The following persons were re-elected as TC Chairs for the period 06/2021 to 05/2023:

 Zoltan Zelenka (BEV, Austria) was elected as new TC-M Chair, for the period 06/2021 to 05/2023.

- Paul Hetherington (NSAI, Ireland) was re-elected for a second term of office as Member of the Internal Audit Committee for the period from 06/2021 to 05/2024
- The GA approved the "EURAMET Strategy 2030", which would be further detailed in G15.10.



- On the European Partnership on Metrology, that is planned to succeed the EMPIR research programme, the Delegates were given an overview on the state of play. A presentation would be given in G15.09. to further detail ongoing developments.
- The GA approved the establishment of two new EMNs on "radiation protection" and "advanced manufacturing".
- The GA appointed Hans Arne Frøystein as the convenor of the GA WG on EMNs, as Jörn Stenger becomes the EURAMET Chairperson.
- Regarding the internal organisation, the GA took note of a healthy financial situation, good quality management practices as well as the progress made towards KPIs despite the pandemic that slowed down or prevented some related activities (e.g. physical CB training sessions).
- The EURAMET GA 2022 will take place in Vienna, Austria in the week from 30th May to 2nd June.

G15.04 European Metrology Networks (EMN Summaries)

G15.04.01 Developments of EMNs and New EMNs

As the convenor of the GA WG on EMNs, Jörn Stenger gave an overview of the development of the EMNs, highlighting in particular the establishment of the two new ones that were approved the day before; Radiation Protection and Advanced manufacturing. Together with the first 7 EMNs established (Mathmet, Quantum Technologies, Laboratory Medicine, Smart Electrical grids, Energy Gases, Climate and Ocean Observation, and SmartNorth), they formed a sound group of networks addressing the Horizon Europe challenges. Jörn added that other EMNs were in preparation with the potential to complete the current landscape and better achieve EURAMET objectives.

The proposers of the most recently established EMNs presented the scope and objectives of their networks.

End of 1st day of the Plenary Session

2nd Day of the Plenary Session – 9th June 2021

Hans Arne, welcomed the participants and started by thanking BoD member Aigar Vaigu for organising a very pleasant virtual social event on the previous evening.

G15.09 The Partnership on Metrology – Status

General Secretary Duncan Jarvis gave an overview on the development status of the European Partnership on Metrology that will succeed the EMPIR research programme.

He highlighted the current intense / daily discussions with the Commission and MEPs. In making things progress as smoothly and rapidly as possible, and have a favourable final decision by the Autumn 2021, Duncan invited the Delegates to promote our proposal in their respective Ministries and Parliaments, and Research Attachés in Brussels.

G15.10 EURAMET Strategy 2030

Hans Arne presented the EURAMET Strategy 2030 document [19]. This key text defines the overall approach of the Association to ensure the continuity of the activities developed so far, and to establish a world class, European metrology infrastructure.

After detailing the overall process to develop this new strategy, he highlighted the main changes compared to the previous strategy document. Our vision and mission, and related objectives to achieve



them were then further detailed (please consult the related PP-slides among the meeting documents for further details).

Finally, Hans Arne thanked the BoD, TC and EMN Chairs, the Research Council and EURAMET Delegates for their contributions in developing this document that will lead EURAMET activity over the current decade.

G15.11 Dialogue with the BoD

Hans Arne opened the dialogue with the BoD, inviting the participants to ask any questions, comments or suggestions they had.

José Ángel Robles Carbonell, (CEM, Spain). Asked if there had been any report on the implementation results of the former strategy. Hans Arne replied explaining that the new strategy was developed following an analysis of the achievements against the previous strategy. Jörn confirmed that the new strategy document was structured along this review with sections headed "we have" and "we will" against each goal.

Annette Röttger commented that within CC-RI there had been discussions to better understand EMNs (scope, mission and activities) developments and wondered how the EURAMET communication strategy could address this information need.

She also reported that there are currently similar discussions to define the CIPM strategy to address major challenges as related to the development of EURAMET / EMN strategy. As we seem to be slightly ahead, Annette wondered how EURAMET could contribute.

Hans Arne and Jörn recommended to establish a dialogue between CCs / the CIPM and EURAMET / EMNs to explain EMN activities and further develop collaboration and learn to develop better. They also invited APMP focus groups to link and share experiences with the EMNs.

Rado Lapuh (MIRS, Slovenia), informed that in Slovenia they are willing to align their national metrology strategy to the EC recommended exit strategy with no institutionalised partnership to continue supporting metrology R&D. Understanding that EMNs are a pillar of that, he asked for further support and visibility to align and initiate that paradigm change. Hans Arne confirmed the importance to keep on working in close collaboration with the Commission to get as much support as possible even after 2027.

G15.12 Chair Handover

Hans Arne and Jörn thanked Gustaf Winroth for his great support in supporting the partnership proposal until now; as well his colleagues Sean O'Reagain, Jürgen Tiedje, Peter Dröll, and Jörg Niehoff who defended our work and proposal in the Commission and Council.

They expressed their gratitude to Duncan who will retire as General Secretary when Mikko takes over later this year. They appreciate very much that he will continue in a part time role for ICT tasks and



being available to support the incoming GS. Hans Arne highlighted the good, strong support to him, and our association and the metrology community, as the top manager for the Secretariat, and in particular in the important strategic topics during the last years, the development of the Partnership, and our new strategy.

Hans Arne thanked EURAMET colleagues who accompanied him as Chairperson over his term, giving him lots of energy to perform, as well as his Director General Geir Samuelsen for allowing him to take on the task, and colleagues at JV (Norway) for being very supportive. Reflecting on his mission statement, he underlined that the association together had advanced well on many of the important challenges we faced three years ago, He expressed gratitude to the Secretariat, the MSU, the BoD, TC Chairs, for support in the JCRB from Kai, Miruna, Julien and Wolfgang, the EMN Chairs, Delegates and Alternates, EMPIR Committee representatives and the Research Council. Finally, he showed appreciation to the Commission and other European stakeholders, MEPs, and Partnerships for their ongoing collaboration with EURAMET. In addition to the Commission colleagues mentioned above he also very much appreciated the support from Director General Jean-Eric Paquet and Deputy Director Signe Ratso for their strong support.

He gave the floor to Jörn offering him his support as past-Chair and wishing him success in his Chair position.

Jörn acknowledged the leading contribution and diplomacy of Hans Arne in a particularly dynamic time with the launch of EMNs, transition to the next programme, EURAMET Strategy 2030, assuring liaison activities with other RMOs and organisations, and good cohesion within the association and the Secretariat despite Covid-19. All that made Hans Arne's Chair term one of the most successful in the Association's history.

Jörn promised to take Hans Arne's achievements forward, guided by the 2030 strategy, and with a focus on the Partnership, EMN development, digitalisation, and regulation, but making sure that EURAMET maintains its relevance for the members in supporting the MRA. Stakeholder interactions will be key, in particular with the EC, other Partnerships and other European and international Partners like WELMEC and the RMOs. Jörn said that he wishes to talk to all delegates, representatives of liaison organisations and TC and EMN Chairs individually to learn more about their views and expectations. Ultimately, he wishes to increase the benefits to EURAMET's members.

Following that handover, Jörn called for the last point in the agenda.

G15.13 AOB

Mikko Merimaa thanked Hans Arne and Jörn for the opportunity given to join the GA before starting, and expressed gratitude to Duncan for assuring a transition period with him until the end of the year.

Pavel Neyezhmakov wished a prosperous future to EURAMET, and looked forward to collaborating with Jörn to further develop cooperation between COOMET and EURAMET.

With no other business to be discussed, Jörn Stenger closed the meeting.
