#### **Decision of the GA**

"Acknowledging that the membership fees were last time increased in 2009, EURAMET Membership Unit Charge is increased by 50 % from 2024 onwards to cover the cost of Member Services. The DI and Associate fees are increased proportionally."


This will lead to a total income of **385 656** € in 2024 from our 37 NMIs, 76 Dis, and 3 Associates.

## Liaison Organisations: present situation



- Our policy: EURAMET maintains permanent relationship with governmental or non-governmental national or international organisations and institutions with activities relating to the field of metrology.
- EURAMET Liaison Organisations can be:
  - Regional Metrology Organisations (LO-RMO)
  - Corresponding NMIs (LO-NMI)
  - Corresponding Organisations (LO-CO)
- EURAMET has concluded Memoranda of Understanding with organisations outside these categories
- EURAMET has the ambition to further develop cooperations with partner organisations
